Quarterly Dues Amount

Families with four or more swimmers will receive a 50% discount off the regular price of the fourth, fifth, sixth... swimmers. The discount will be applied to the swimmers(s) in the most novice swim group from the family.

Due Dates

The total Dues for each Quarterly Session are due the 1st of the month of each Session and must be submitted by the 20th of that month to avoid paying a late fee.

Sessions

I	II	III	IV
Sept – Nov	Dec – Feb	Mar – May	June – Aug

Payment Options

Dues payment either in one check for full amount or three post-dated checks dated the first of each Session's month.

Pro-ration of Dues

1. Not applicable to existing and/or returning BAC swimmers; all Dues are paid at the beginning of the Session.
2. Dues for first time BAC swimmers, who join BAC within a Session, are prorated on a monthly basis.

Penalty for Late Payment

1. If Dues are not paid by the 20th of the month, a \$25 late fee will be assessed.
2. If Dues are unpaid for more than 45 days; Board is notified and swimmer is suspended from all membership privileges.
3. If Dues are unpaid for more than 60 days, member is declared to not be in good standing and membership is terminated (requires Board approval).
4. Members terminated in such fashion must petition the Board for possible re-admittance into BAC. Such re-admittance will be at the Board's discretion.
5. Members should contact a Board member to discuss extenuating circumstances. The Board will address such situations on a case-by-case basis.

Switching Practice Groups

Once a swimmer has been established for a Session (joint decision between Coach and swimmer's parents), the swimmer cannot be changed unless space is available in the desired Practice Group and a Coach approves the switch (swimmer's parents must submit Practice Group Switching Form or Coach may recommend a Practice Group change).

Refunds and Credits

1. Refunds will be granted for relocation and medical reasons according to the individual situation. Swimmers who relocate out of the area will receive a refund for the unused portion of their Dues. Refund will be based on a monthly pro-ration and never be for more than two months of Dues.
2. Credits for unused Dues will be granted only when a swimmer must withdraw for medical reasons. A written request must be submitted to the Treasurer, along with a doctor's written verification of the swimmer's inability to swim. This credit must be used within the following 12 month period. A refund will be granted in lieu of a credit only to those swimmers who will not be able to use the credit in the following 12 months. Refunds and credits will be based on a monthly pro-ration and never be for more than two months of Dues.

Try Out Week (1st week of each month)

First time BAC swimmers are eligible for a free Try out Week (once per Session). If the swimmer chooses to join BAC, the swimmer owes Dues for the entire Session (pro-ration of Session dues, if necessary, as specified above). If swimmer chooses to not join BAC, nothing is owed.

Miscellaneous

BAC members who submit a check that is returned due to insufficient funds will be assessed a \$25 charge.
